ARTICLES OF ORGANIZATION

1. The Name of the limited liability company is: First Coast Scaffolding, LLC (the "Company") and the principal office address is 4960 Stepp Avenue, Jacksonville, Florida 32216.

2. The date of filing of the Articles of Organization of the Company was November 28, 2001, as amended on July 29, 2002 and June 12, 2009 and assigned document number L01000020786.
