**ARTICLES OF ORGANIZATION
OF
BACK ON TRACK, LLC**

The undersigned Organizers of a limited liability company organized under the Florida Limited Liability Company Act does hereby adopt the following Articles of Organization for such limited liability company.

**ARTICLE I
NAME OF THE LIMITED LIABILITY COMPANY**

The name of the limited liability company shall be Back on Track, LLC.

**ARTICLE II
ADDRESS**

PERIOD OF DURATION**

**ARTICLE V
WRITTEN OPERATING AGREEMENT**

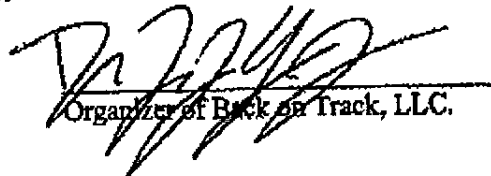
ARTICLE VII ADMISSION OF ADDITIONAL MEMBERS

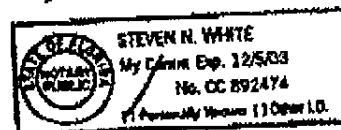

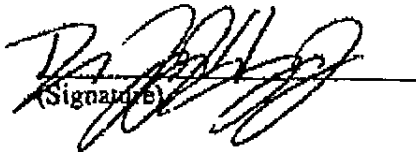
