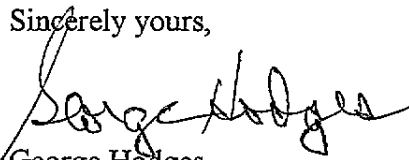

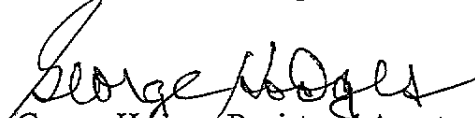

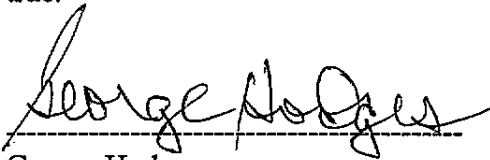
ARTICLE V – Effective Date
