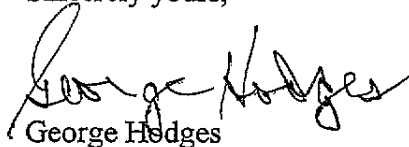

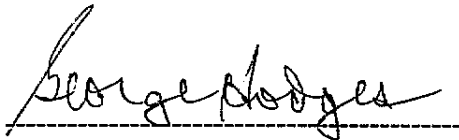
## ARTICLE V – Effective Date
