ARTICLES OF ORGANIZATION

OF

SERGEI KALMIKOV CULTURAL FOUNDATION, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **SERGEI KALMIKOV CULTURAL FOUNDATION, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 25 Pelican Court, Palm Coast, Florida 32137 and the mailing address shall be the same.

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.




