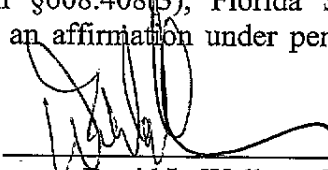
## **ARTICLE VI** **MANAGEMENT PROVISIONS**
