To Whom it may concern,

A few minutes ago I completed a phone conversation with a gentleman in your office and he suggested that I write to you.

I awoke this morning with the express purpose of doing paperwork. One of my tasks on my to do list was to-file my UBR's-for my three Florida Entities, Sundancer Marine, Inc., Rising Sun Fisheries, Inc., and Fisher's Seafood Market, LLC., as I knew the May 15<sup>th</sup> deadline was approaching.

You can imagine my horror when I read that the deadline was May  $1^{\rm st}$ , Not the  $15^{\rm th}$ , and that there is a subsequent penalty.

I received my UBR's sometime in February, just as my 13 month old son was admitted to All Children's Hospital for an emergency abdominal procedure to correct a birth anomaly effecting his digestive tract. We were in the hospital 24 hrs a day for ten days, and I was coming home for an hour or so a day to pay bills and do filing. When I received the UBR's I filed them under "to Do for May, and put in my mind a due date of May 15<sup>th</sup>.

As a result of my son's hospitalization and problems with the insurance company, and a month long federally mandated closure of the grouper fishery from Feb 15 $^{\sim}$  March 15 $^{\rm th}$ , my financial state was grim and I was holding off sending in the filing fees until May. I knew as the fish started coming again finances would ease.

I made a mistake. It is an honest mistake. I plead for some leniency-considering my mitigating circumstances.
