ARTICLES OF ORGANIZATION OF ST AVIATION LLC

The undersigned, acting as the organizing Member of this limited liability company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for said limited liability company:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY

The name of this limited liability company shall be ST AVIATION LLC.

ARTICLE II - PERIOD OF DURATION

The period of duration of this limited liability company shall commence as of the 3rd day of December, 2001, and shall continue until dissolution not later than December 31, 2029.

Edward Johnson. The Members may from time to time designate a new registered agent.

ARTICLE V - MANAGEMENT

This limited liability company shall be managed by the Members according to the Operating Agreement of this limited liability company.

ARTICLE VI - NEW MEMBERS

Additional persons may be admitted to this limited liability company as Members only with the prior written consent of existing Members holding not less than sixty-seven percent (67%) of the Member interests.

ARTICLE VII - CONTINUATION

The members of this limited liability company may elect to continue the existence of this limited liability company on death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in this limited liability company, on the affirmative vote of not less than sixty-seven percent (67%) of the member interests entitled to vote as provided in the operating agreement.

<u>ARTICLE IX - INDEMNIFICATION</u>

This limited liability company shall indemnify the Members, or any former Member to the full extent permitted by law.
