ARTICLES OF ORGANIZATION

A LIMITED LIABILITY COMPANY

(Pursuant to s. 607.407, Florida Statutes)

1. The name of the limited liability company is Oude Wijnberg Export, LLC.

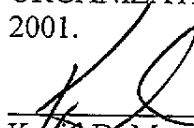

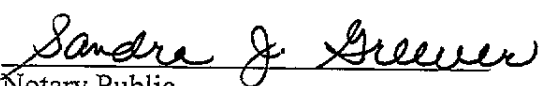

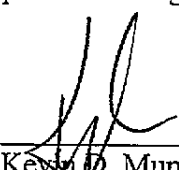
