The mailing address and street address of the principal office of the Company is 112 Buck Island Court, Ponte Vedra Beach, Florida 32082.

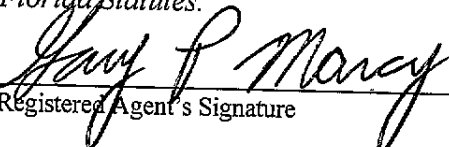
ARTICLE III

ARTICLE VI

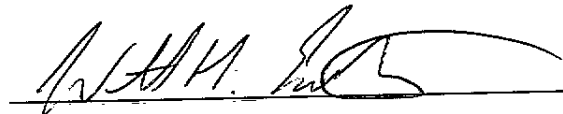
ARTICLES OF ORGANIZATION AND OPERATING AGREEMENT
