ARTICLE I - Name

ARTICLE VI - LIMITATION ON AGENCY AUTHORITY OF MEMBERS

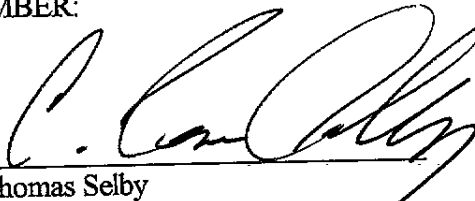
