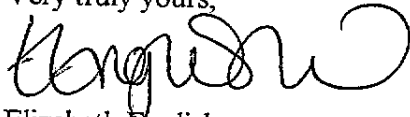

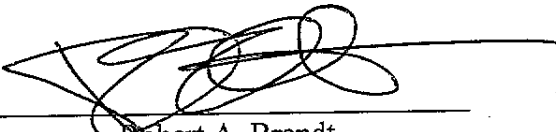
ARTICLE V - MANAGEMENT OF LLC
