The initial member of this limited liability company is TEDDY RAY HUNT, JR.

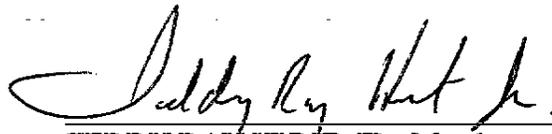
ARTICLE VIII

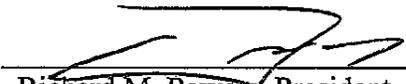
