Management of the Company is reserved to its members.

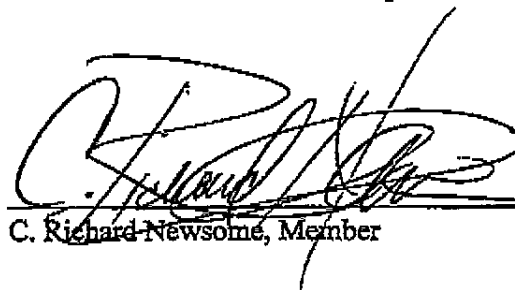

The effective date of these Articles of Organization, and the commencement of the existence of the Company, shall be the date of filing of these Articles of Organization.

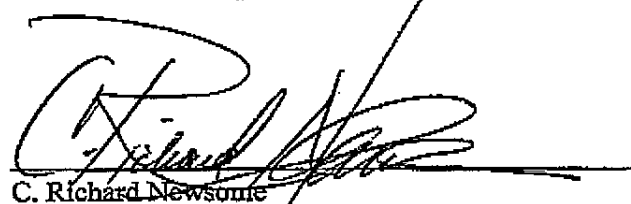
