**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF**

NORA INVESTMENTS, L.L.C.

The undersigned, for the purpose of amending and restating the Articles of Organization of the limited liability company entitled Nora Investments, LLC organized under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization for Nora Investments, LLC.

ARTICLE I -- NAME

The name of the limited liability company shall be Nora Investments, L.L.C. as was shown in the original articles.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 2899 West 2nd Avenue, Hialeah, Florida 33010, which is the same as shown in the original articles.

ARTICLE III -- DURATION

The company commenced its existence on December 13, 2001 which is the date that the original articles of organization were filed with the Florida Department of State. The company's existence shall terminate on December 12, 2031 unless the company is dissolved earlier, as provided in these articles of organization or in the regulations.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is the same as was shown in the original Articles.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The sole member of the company shall contribute to the capital of the company the cash amount(s) as set forth in the Affidavit of Membership and Contribution attached hereto as Exhibit "A".

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

The member may make additional capital contributions to the company as provided in the regulations.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

No additional member(s) shall be admitted to the company except with the unanimous written consent of the existing member of the company and on the terms and conditions as shall be determined by that member. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless the member proposing to dispose of his or her interest approves of the proposed transfer by written consent.

ARTICLE VIII -- MEMBER'S RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of its member and manager, or on the occurrence of any other event that terminates the continued membership of the member in the company, unless the business of the company is continued by unanimous vote of any remaining member(s) as provided in the regulations or operating agreement.

ARTICLE IX -- MANAGEMENT

The company shall be managed by its sole Member in accordance with regulations and/or operating agreement adopted by the member for the management of the business and affairs of the company. These regulations and/or operating agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 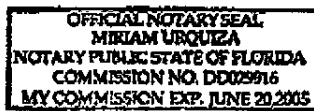
