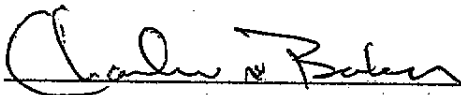
1. **Name.** The name of the Company is Alamo, TX Post Office, L.L.C.

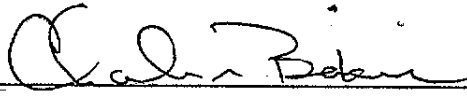
