ARTICLES OF ORGANIZATION

OF

a Florida limited liability company

1. The name of this limited liability company is WEST MAST, LLC (the "Company").

7. The Company is to be managed by one or more managers. The name and address of the initial manager is as follows:



The foregoing right of indemnification shall not be exclusive of any other rights to which any officer, employee or agent may be entitled as a matter of law or which she may be lawfully granted.
