**ARTICLES OF DISSOLUTION  
OF

Pursuant to Section 608.445 of the Florida Limited Liability Company Act (the "Act"), Bear Creek Lessor/LLC, a Florida limited liability company (the "Company") hereby submits the following Articles of Dissolution to the Florida Department of State.

1. The name of Company is Bear Creek Lessor/LLC.
2. The effective date of the Company's dissolution is September 21, 2010.
3. The dissolution occurred, in accordance with the Company's Chapter 11 Plan of Reorganization as approved by the Confirmation Order of the United States Bankruptcy Court for the Middle District of Tennessee and in accordance with the operating agreement of the Company, by the unanimous written consent of the Board of Directors of the sole member of the Company to dissolve the Company, dated September 21, 2010.
4. All debts, obligations, and liabilities of the Company have been paid or discharged, or adequate provision has been made therefore pursuant to Section 608.4421 of the Act.
5. All the remaining property and assets of the Company have been distributed to the sole member.
6. There are no suits pending against the Company in any court.
