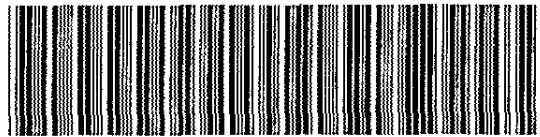

ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF  
MIPEC, L.L.C.

- FIRST:** The date of filing of the Articles of Organization was December 14, 2001.
- SECOND:** The following amendment to the Articles of Organization was adopted by the limited liability company:

Article I of the Articles of Organization is deleted and replaced by the following:

ARTICLE I  
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be International Trading, L.L.C. and its principal office shall be located at 3035 Bayshore Road in the City of Sarasota, County of Sarasota, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
