**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
WADSS REAL ESTATE HOLDINGS, L.L.C.**

The undersigned, being a Member of WADSS Real Estate Holdings, L.L.C., a Florida limited liability company (the "Company"), in accordance with the provisions of the Florida Revised Limited Liability Company Act, hereby amends the Company's Articles of Organization as set forth below:


1. The name of the Company is WADSS Real Estate Holdings, L.L.C.
2. The Articles of Organization of the Company were filed with the Florida Department of State on December 18, 2001. The Florida Document Number for the Company is L01000021910.
3. Article IV of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

**"ARTICLE IV.
MANAGEMENT**

The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The authority and duties of the Managers shall be as set forth in the Operating Agreement of the Limited Liability Company."

4. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
