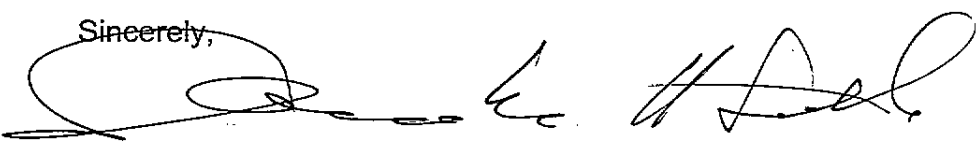

The name of this limited liability company is **CR PARTNERS IV, LLC**, a Florida limited liability company.

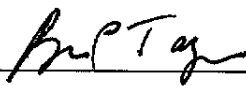

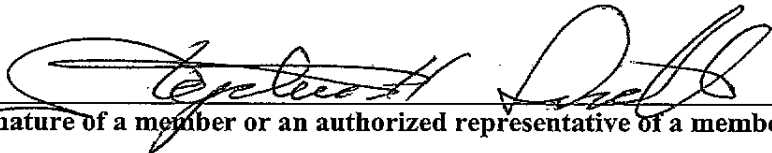
