**ARTICLES OF ORGANIZATION  
FOR  
DONALD D. STODDARD, M.D., LLC**

**A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as the organizer and as the initial Member of DONALD D. STODDARD, M.D., LLC (the "Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is DONALD D. STODDARD, M.D., LLC.

**ARTICLE II  
PURPOSE AND POWERS**

A. Purposes. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.

B. Powers. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, Fla. Stat., as the same may be amended from time to time.

**ARTICLE III
