**ARTICLES OF ORGANIZATION FOR**

**ARTICLE I – Name:**

The name of the Limited Liability Company is:

#### **ARTICLE IV: Profit & Loses:**

- a. **SHARING OF PROFITS:** The members shall be entitled to the net profits arising from the operation of limited liability business that remains after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to their distributive share of the profits according to their percent of interest in the company.
- b. **LOSES:** All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business or if such sources are insufficient to cover such losses, by the members in shares as set forth in the percentages alongside the name of each member according to their percent of interest in the company.

#### **ARTICLE V – Duration:**

The company's existence shall terminate not later than December 31, 2099, unless the company is earlier dissolved as provided in these articles of organization or adopted by members.

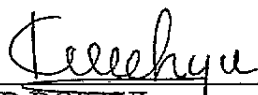
#### **ARTICLE VIII – Members Rights to Continue Business:**

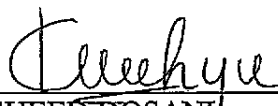
