**ARTICLES OF ORGANIZATION
OF
ADDISON CUSTOM HOMES OF ORLANDO, LLC**

The undersigned hereby executes these Articles of Organization (“Articles”) for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the “Company”) shall be:

Addison Custom Homes of Orlando, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in




