Management of the Limited Liability Company shall be by a Manager or Managers and the name and address of the initial Manager is:

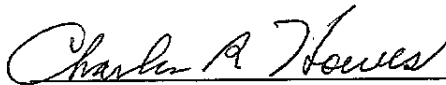

The power to adopt, alter, amend, and repeal the Operating Agreement is vested in the Managing Members.

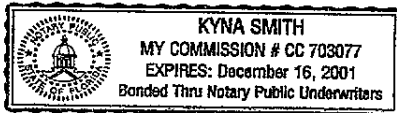
