ARTICLES OF ORGANIZATION OF ALICO/75 PROPERTY, L.L.C., A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I NAME

The name of this limited liability company is Alico/75 Property, L.L.C., referred to in these Articles of Organization as the "Company."
