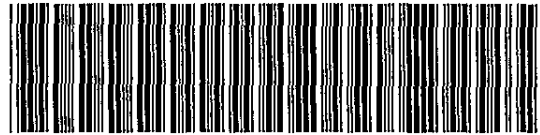



All Members of this Limited Liability Company have agreed to change the new name to read: PEACH, L.L.C.


