**ARTICLES OF ORGANIZATION
OF
FROM SOUP TO NUTS, LLC**

The undersigned, intending to form a limited liability company under the Florida Limited Liability Company Act, declares that the following Articles of Organization shall serve as the Charter and authority for the conduct of business of the limited liability company.

**ARTICLE I
NAME**

This name of the limited liability company shall be From Soup to Nuts, LLC.

**ARTICLE II
ADDRESS**

The limited liability company is to be managed by one or more managers, who may or may not be members. The initial manager of this Company shall be Pamela J. Renae.



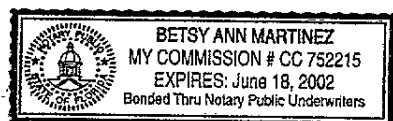


