repairing, replacing, constructing, improving and financing, on a secured and unsecured basis, real and personal property of every kind, nature and description.

The Limited Liability Company shall have the same powers as an individual to do all things necessary or convenient to conduct its business and affairs, including, without limitation, all powers now and hereafter authorized under the laws of the United States and the State of Florida.

**ARTICLE VI — Admission of Additional Members**

**ARTICLE VIII – EXECUTION OF INSTRUMENTS AND DOCUMENTS**

Any instrument or document with respect to the acquisition, mortgage or disposition of any property of the Limited Liability Company, including but not limited to deeds, notes, bonds, mortgages, leases, releases and contracts of every nature executed by the then Manager of the Limited Liability Company shall be valid and binding upon the Limited Liability Company and no consent or permission shall be required from any Member.

**ARTICLE IX – REGULATIONS**


**ARTICLE X – COMMENCEMENT OF EXISTENCE**


**ARTICLE XI – DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE**
