

**ARTICLES OF ORGANIZATION
OF
SUMTER-PRICE, LLC**

1. **NAME.** The name of this limited liability company is Sumter-Price, LLC (the Company), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
2. **PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 12360 66th Street N., Suite H, Largo, Florida 33713.
