ARTICLES OF ORGANIZATION

The undersigned member, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be 7596 MERRILL ROAD, L.L.C. ("Company").

ARTICLE II -- ADDRESS

The mailing address of the Company shall be 837 North Street, Jacksonville, Florida 32211, and its principal office shall 7695 Merrill Road, Jacksonville, Florida 32211.

ARTICLE III -- EFFECTIVE DATE; DURATION

The Company shall commence its existence on December 26, 2001. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided by law.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE VII -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the operating agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE IX -- MANAGEMENT

The Company shall be managed by a manager in accordance with regulations set forth in the operating agreement adopted by the members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the
