MANAGEMENT

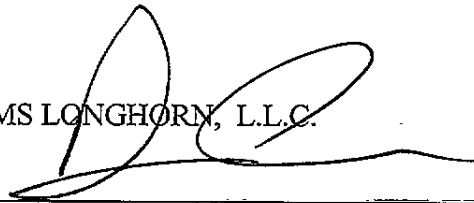
