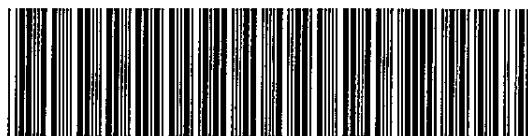

ARTICLE III - Amendment:

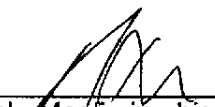
The Articles of Organization of the Company are hereby amended by deleting Article IV thereof in its entirety and substituting in its place the following language:

The Company is to be managed by a Manager and the name and address of the initial Manager is:

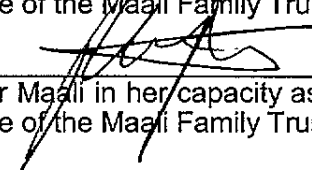
