ARTICLES OF ORGANIZATION OF

GARY L. TOST, O.D., L.C.

The undersigned certifies that the person listed in Article III hereinafter desires to form a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit. It is further declared that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

Article I

Name and Principal Place of Business

The name of the limited liability company shall be **GARY L. 6.
