ARTICLES OF ORGANIZATION OF SOSUSTE, L.L.C.

A Limited Liability Company

The undersigned signator of these Articles of Organization, competent to contract, does hereby make declaration to form a limited liability corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the limited liability company will be SOSUSTE, L.L.C., a limited liability company.

ARTICLE II - ADDRESS

The initial post office and mailing address of the principle office of the limited liability company in the State of Florida is 212 Pablo Court, Ponte Vedra, Florida 32082.

ARTICLE III - OBJECTIVES AND POWERS

This company is formed for the purpose of owning farm and investment livestock and farm equipment.

However, the foregoing, shall in no way limit the company from engaging in any activity or business permitted under the laws of the United States and of this State and shall include the power to:

 - 6. Make contracts or guarantees, or incur liabilities and borrow money.
- 7. Lend money, invest or reinvest it's funds, and receive and hold real or personal property as security for repayment.
- 8. Conduct it's business, locate offices, and exercise the powers granted by this chapter within or without this State.
- 9. Select managers and appoint officers, directors employees, and agents of the limited liability company, define their duties, fix their compensation, and lend them money and credit.
- 10. Make donations for the public welfare or for charitable, scientific or educational purposes.
- 11. Pay pensions and establish pension plans, pension trusts, profit-sharing plans, bonus plans, option plans and benefit or incentive plans for any or all of it's current or former managers, members, officers, agents, and employees.
- 12. Be a promoter, incorporator, shareholder, partner, member, associate or manager of any corporation or partnership, joint venture, trust or other entity.
- 13. Make payments or donations or do any other act not inconsistent with law that furthers the business of the limited liability company.

14. Possess all powers granted to the company by section 608.404, Florida Statutes.

ARTICLE IV - REGISTERED AGENT

ARTICLE VI - AMENDMENT

These articles of organization may be amended from time to time upon the discretion of the managing member as provided in section 608.4321, Florida Statutes.

ARTICLE VII - DESIGNATION OF MEMBERS

There will be two (2) initial members of the company, to wit: Susannah Borg and Stefan Borg. No additional member may be admitted pursuant to provisions of section 608.4232, Florida Statutes, without the unanimous consent of said members in writing to the admission of the proposed additional member.

ARTICLE VIII - CONTRIBUTIONS, PROFIT AND LOSSES

Each of the two (2) members hereby acknowledge that they have made an equal contribution to the company. Furthermore, profit and losses of the company shall be shared by the members on an equal basis.

<u>ARTICLE IX - ASSIGNMENT</u>

The interest in the company of each member is not assignable in whole or in part unless approved by the other member, in writing. Should an assignment take place, then the provisions of section 608.432, Florida Statutes, as to the assignee shall take effect.

ARTICLE X - APPLICATION OF FLORIDA LAW

All provisions of Chapter 608, Florida Statutes, which are not expressly rejected by these articles, are hereby incorporated by reference and made a part hereof. In any circumstance where these articles are in conflict with the provisions of said Chapter, then the Chapter shall take precedence.
