

This is to inform you that a bill (H.D. 3148) has been introduced by Senator Deborah K. Flanagan, Secretary of State, and approved by the Senate Committee on Rules and Administration, and is now before the House of Representatives.

The bill proposes to require the state auditor to audit the state's financial management system every three years, and to require the auditor to report to the legislature on the results of the audit. The bill also requires the state auditor to provide a report to the legislature on the results of the audit.

Section 1: H.D. 3148-31a, adds § 653.00 to the state auditor's statute; it requires the state auditor to audit the state's financial management system every three years, and to require the auditor to report to the legislature on the results of the audit.
