**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
SAF T LOK INCORPORATED**

Pursuant to the Business Corporation Act of the State of Florida, the undersigned Secretary of Saf T Lok Incorporated (the "Corporation"), a corporation organized and existing under and by virtue of the Business Corporation Act of the State of Florida ("FBCA") bearing Document L01153 does hereby certify:

FIRST: That pursuant to a Written Consent of the Board of Directors dated April 5, 2001, the Board of Directors approved the following amendment to the Corporation's Articles of Incorporation effecting a 1:10 reverse stock split;

SECOND: Article IV of the Articles of Incorporation of the Corporation shall be deleted in its entirety and replaced with the following:

"The maximum number of shares of stock that this Corporation shall be authorized to issue and have outstanding at any one time shall be three million (3,000,000) shares of Common Stock, par value \$.10 per share."

THIRD: On the date of filing of these Articles of Amendment with the Secretary of State of the State of Florida, every ten (10) issued and outstanding shares of the Corporation's previously authorized common stock, par value \$.01 per share (the "Old Common Stock") shall thereby and thereupon be reclassified and converted into one (1) validly issued, fully paid and nonassessable share of common stock, par value \$.10 (the "New Common Stock"). Each certificate that theretofore represented shares of Old Common Stock shall thereafter represent the number of shares of New Common Stock into which the shares of Old Common Stock represented by such certificate were reclassified and converted hereby; provided, however, that each person holding of record a stock certificate or certificates that represented shares of Old Common Stock shall receive, upon surrender of stock certificate or certificates, a new certificate or certificates evidencing and representing the number of shares of New Common Stock to which such person is entitled, except that no fractional shares resulting from the combination shall be issued, any such fractional share to be converted to the right of the holder thereof to receive one share of New Common Stock.

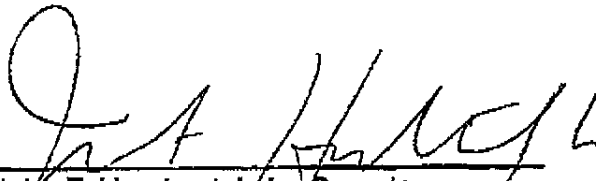

FIFTH: These Articles of Amendment shall be effective as of 7:00 a.m., Florida, time, on the date of filing.

The foregoing amendment was adopted by the Board of Directors of the Corporation pursuant to Written Consent of the Board of Directors on April 5, 2001, pursuant to FBCA Section 607.0821 and Section 607.10025(2).
