ARTICLES OF ORGANIZATION OF ARCHER MINI STORAGE II, L.L.C.

1. Name. The name of the limited liability Company (hereinafter referred to as "Company") is: ARCHER MINI STORAGE II, L.L.C.
2. Existence. The Company shall have perpetual existence commencing January 1, 2002.
