ARTICLE IV

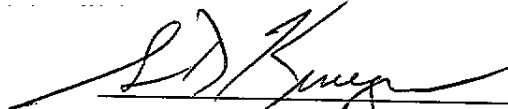

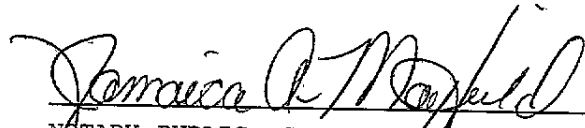

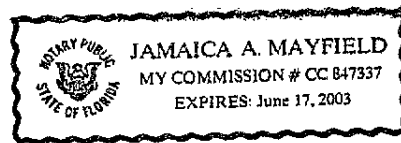
