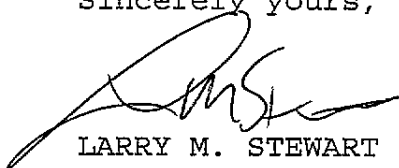

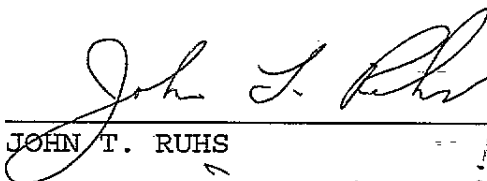
ARTICLE IX - CONTINUATION

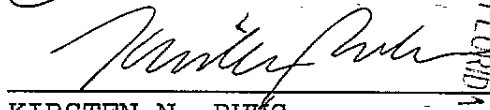
