# ARTICLES OF ORGANIZATION FOR 1200 SOUTH MAIN STREET, LLC

#### ARTICLE I - Name

The name of the Limited Liability Company is 1200 SOUTH MAIN STREET, LLC.

The members will have the right to continue the Company on the death, retirement, resignation, expulsion, bankruptey or dissolution of a member or occurrence of any event which terminates the continued membership of a member in the Company (collectively "Withdrawal"), as long as there is at least one (1) remaining member, and the remaining member(s) agree to continue the Company by unanimous written consent within ninety (90) days after the Withdrawal of a member, as set forth in the Operating Agreement of the Company.
