AGREEMENT AND PLAN OF MERGER

THIS AGREEMENT AND PLAN OF MERGER of WEST COAST SELF STORAGE #2, L.L.C., a Florida limited liability company, and BS #3, L.L.C., a Florida limited liability company, pursuant to Chapter 608 of the Florida Statutes, is adopted as follows:

- A. WEST COAST SELF STORAGE #2, L.L.C., a Florida limited liability company, shall be merged into BS #3, L.L.C., a Florida limited liability company, existing under the laws of the State of Florida (the "Merger").
- B. The name of the surviving limited liability company or business entity shall be BS #3, L.L.C., a Florida limited liability company.
- C. When the Merger becomes effective the existence of WEST COAST SELF STORAGE #2, L.L.C., a Florida limited liability company, shall cease and the surviving entity, BS #3, L.L.C., a Florida limited liability company, shall succeed, without any other transfer, to all of the rights and property of WEST COAST SELF STORAGE #2, L.L.C., a Florida limited liability company, and shall be subjected to all of the debts and liabilities of said merged limited liability company in the same manner as if the surviving limited liability company had itself incurred the same.
