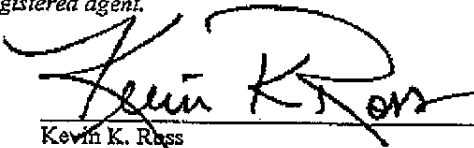

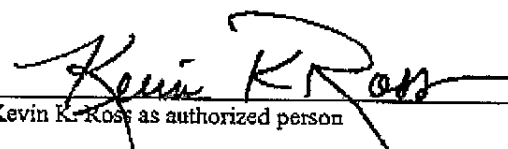
**ARTICLE EIGHT
