ARTICLE III- Duration

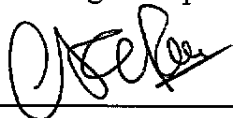

ARTICLE V- Percentage Interest: Membership Certificate

The profits and losses of the Company shall be allocated to the members in accordance with and in proportion to each member's Percentage Interest (which shall be equal to the number of Units owned by a member divided by the total number of Units owned by all of the members), unless otherwise provided in the Regulations of the Company. A member's interest in the Company may be evidence by a Membership Certificate issued by the Company.

ARTICLE VI-Admission of Additional Members

The right, of the remaining members to admit additional members and the terms and conditions of the admission shall require a unanimous agreement among the existing members setting forth number of additional members, and the terms and conditions of their admission:

ARTICLE VII- Members Rights to continue Business

The right, if given of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be: **Upon the remaining member(s)'s purchase of the departing member's value in the Company, based on fair market value and/or an independent appraisal of same.**

- 1) The above named **Limited Liability Company** has at least one member
- 2) The total of cash contributed by the members is **at least \$ 10**
- 3) The total amount of cash or property anticipated to be contributed by the members is **\$ 900,000,000.00 or less.**

ARTICLE VIII- Transferability of Member's interest

No member shall have the right to assign the member's interest in the Company without the written agreement of a majority of the Units. If a majority of the Units do not approve the assignment, the assignee shall have no right to become a member, to participate in the management of the Company or to exercise any other rights or powers of a member. The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.
