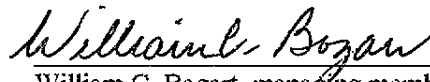

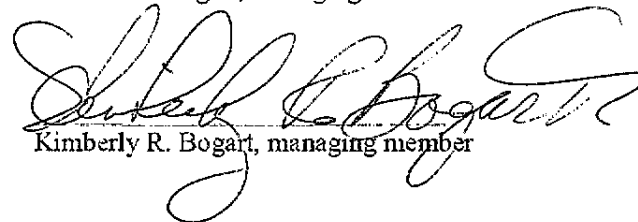
and the distribution of profits from the sale or transfer of a Company asset or assets shall be established.
