

**ARTICLES OF ORGANIZATION
OF
MEDIAPTIVA, LLC**

**ARTICLE I
NAME**

The name of the limited liability company is MEDIAPTIVA, LLC (the "Company").

**ARTICLE II
ADDRESS**

DURATION AND CONTINUATION**
