The undersigned, Valerie Bonanno, desires to form a limited liability company pursuant to the Florida Limited Liability Company Act. As one of the members of the proposed limited liability company, he does hereby make and file these Articles of Organization, and hereby declares and affirms:

ARTICLE I: Name

The name of the limited liability company ("Company") is SunCoast Concierge, LLC, a Florida Liability Company.

ARTICLE II: Street Address and Mailing Address

ARTICLE III: Duration

ARTICLE V: Admission of New Members

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE VI: Pre-emptive Rights

As a function of the agreed value of the initial contributions of the members of this limited liability, each member will have a proportionate percentage or other interest in the profits and losses of the company. Thereafter, as the members make subsequent contributions to capital or receive distributions of capital, the members shall have "pre-emptive rights" meaning (in the case of this limited liability company) the right to make such subsequent contributions to capital, and to receive distributions from capital in a manner which will allow the members of the limited liability company to maintain their respective proportionate percentage or other interest in the profits of the company. If, however, any member fails to make his contribution of cash, property or services within sixty (60) days after request is made for same, then that member's "pre-emptive" rights shall not be in effect for that particular capital call, but shall remain in effect for any subsequent capital call, but without prejudice to any rights, including the right to specific performance, that the limited liability company may have against such member under the articles of organization or operating agreement or applicable law.

ARTICLE VII: Continuation Provisions

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

ARTICLE VIII: Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the members of the Company.
