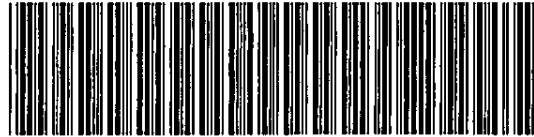

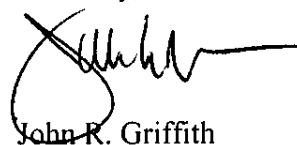

RESOLVED, that the Articles of Organization be, and the same are hereby, amended so that Article I is deleted in its entirety and the following Article I is substituted therefor:

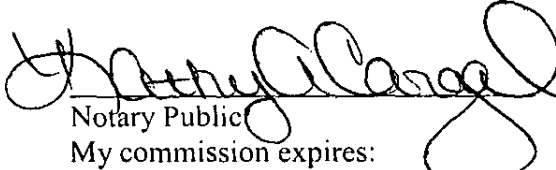

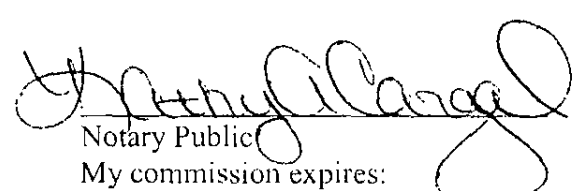
