AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
RAINFOREST VENTURES, LLC

(a Florida limited liability company)

Jeffery A. Bahnsen, a duly authorized representative of the members of RAINFOREST VENTURES LLC, a Florida limited liability company (the "Company"), hereby certifies that:

1. The name of the Company is Rainforest Ventures, LLC. The Articles of Organization of the Company were filed with the Secretary of State of the State of Florida on January 11, 2002.
2. These Amended and Restated Articles of Organization restate, integrate and amend the provisions of the Company's Articles of Organization.
3. The terms and provisions of these Amended and Restated Articles of Organization were adopted by the members of the Company pursuant to a written action without a meeting executed as of and effective February 4, 2002.
4. The Articles of Organization of the Company are hereby amended and restated in their entirety as follows to, among other things, delete certain articles thereof not required under Florida law:

"ARTICLE I. The name of the Limited Liability Company shall be Rainforest Ventures, LLC.


ARTICLE II. The mailing address of the principal office of the Limited Liability Company shall be 1712 Long Bow Lane, Clearwater, Florida 33764.

ARTICLE III. The registered agent for the Limited Liability Company shall be Spiegel & Utrera, P.A., and the Florida street address for the registered agent is 1840 Southwest Street, 4th Floor, Miami, Florida 33145.

ARTICLE IV. The Limited Liability Company shall be a manager-managed company."

5. These Amended and Restated Articles of Organization of Rainforest Ventures, LLC, dated as of February 12, 2002, are being duly executed and filed by Jeffery A. Bahnsen, a duly authorized representative of the members of the Company in accordance with the Florida Limited Liability Company Act (Chapter 608 of the Florida Statutes).
