7. **Amendment of Articles.** These articles may be amended by member.

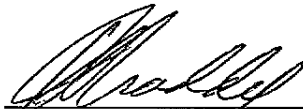
8. **Election of Flexibility.** The Company elects to be a flexible limited liability company as provided and allowed by the laws of the State of Florida.
